## CENTER POLICIES AND PROCEDURES

By using the Center, you agree to follow Center Policies, which may be amended from time to time. Policies can be found online at [www.hallettcenter.com](http://www.hallettcenter.com) or at the service desk upon request.

## CANCELLATION POLICY TERM MEMBERSHIP

You have applied for a term membership. In consideration thereof, and notwithstanding any of the other terms and conditions of the Agreement, you shall be liable for dues and services for the full term of this Agreement in the amount as stated herein, regardless of usage. You may choose to notify the Center before the membership expires that you would like to continue from month-to-month at the prevailing rate, which is subject to change, until **thirty (30) days written notice of termination is provided by you to the Center.**

## MONTH TO MONTH MEMBERSHIP

In order to terminate a month to month membership, a thirty (30) day written notice is required, regardless of usage, by the 10th of the preceding month. Next months dues are required at the time of enrollment if the date of enrollment is on or after the 20th of the month.

## PAST DUE ACCOUNTS

**Membership accounts must remain current.** In order to remain current, payments are due on or about the 5th of each month. Any member whose payment does not process will have his/her membership privileges terminated. Memberships, 24/7 keys, locker rentals, or usage of any services will be suspended until payment is made in full. If the payment is not made within 60 days, the individual will have to pay their past dues and re-enroll in a membership if they wish to continue.

**Return Charges:** Checks and Credit cards returned for non-sufficient funds (NSF) may be sent directly to a check collection services and may not be handled by the Center. NSF checks are subject to a \$30 fee.

## MEMBER'S RIGHT TO CANCEL

If you wish to cancel this Agreement, you may cancel by **delivering or mailing a written notice to the Center.** The notice must say that you do not wish to be bound by the Agreement and must be mailed or delivered before midnight of the third business day after you sign this agreement.

No oral promises are made as a part of this Agreement. Minnesota law governs this Agreement. Whenever possible, each provision of this Agreement shall be interpreted in a manner so that it will be effective and valid under applicable law. If any provision of this Agreement is held invalid, illegal or unenforceable, such provision shall be enforced to the maximum extent permissible and the remaining provisions shall nonetheless be enforceable according to their terms.

No person who has been convicted of, or with an unresolved accusation of any sexual misconduct will be permitted on our premises due to the consistent presence of children in and around the facility. Taking photos or filming of others is not permitted without their prior knowledge and consent. Under no circumstances is any photography or filming permitted within the locker rooms or sauna. No use or possession of alcohol, drugs, or firearms on Hallett Center Property. Smoking, tobacco use, and vaping are not allowed inside or within 20ft of the Center.
